## HISTORICAL NOTES

*The Roman origin of Thiene is certain, confirmed by traces of a rustic building that were brought to light during the archaeological excavations of 1990. The first written document in this regard dates back to the Middle Ages (1107).*

*Thiene became a Free City in 1166. The Ezzelini family occupied it only a few years later, followed by the Scaligeri and the Visconti families during the fourteenth century.*

*The church dedicated to San Vincenzo was built in 1333, commissioned by the noble Thiene family whose descendants still live in the city. The Castle, a splendid example of Venetian Gothic style on the mainland, was built by the noble Porto family and dates back to the early 15th century.*

*Thiene is favourably located at the foot of the Asiago plateau and at the mouth of the Astico Valley and is easily accessible from the A31 motorway. The city has always been a top business centre, a reference point recognised by the whole area. Important contracts are drawn up in the Commodity Exchange of this Business, Industrial and Tertiary City, and the reference prices for the agri-food sector, above all for the dairy sector, are established here and used as a reference for the national market.*

*Tourist, private, business, acrobatic, powered flights take off from and land at the airport dedicated to the aviator from Thiene, A. Ferrarin. This airport also offers gliding, parachuting and flying lessons, including hot air balloon flying lessons!*

*Thiene is also a City of Culture with a Liberty-style theatre, hosting a showcase of national prose, with performances proposed over three evenings, that has been held for 39 years. There is also an Auditorium dedicated to music and many other places that host initiatives and events. The city calendar is full of tourist events that entice thousands of visitors from the surrounding areas and the whole region, for example the historical re-enactment "Thiene 1492", as well as the "Buon Rientro", "Natale di Fiaba", and "Thiene tra Fiori e Sapori" events.*

All the system information is purely administrative and institutional, and it creates a true Network when used together with the ThWeb Portal.

With Open City, users can access information and geolocalised data about everything the city offers, for example: parking areas, public offices, gyms, green areas, schools, polling districts, districts, cycle paths, walking routes and lots more.

### **Extract from the Police Regulations**

The Police Regulations drawn up in 1932 and updated in 2009 are a reference point for citizens, so that they can live together serenely and peacefully.

.....

They are valid for all the public spaces and areas, as well as for all private spaces and areas where public passage is permitted, unless otherwise indicated.

....

## **SECTION 2 : PUBLIC SPACES AND AREAS**

### **Art. 5 : Public spaces and areas.**

The free use of public spaces, as indicated in art. 1 of these Regulations, must be permitted to everyone. Any acts or activities or behaviour that contrast with the indicated purpose of these areas are, therefore, forbidden.

...

### **Art. 6 : Acts that are forbidden in public spaces**

The following are forbidden in public spaces:

- 1) Washing vehicles;
- 2) Stepping on public flower beds of any kind;
- 3) Playing games that can disturb viability, injure or annoy people or animals, or damage buildings or things. Spray cans of any type, friendly ink, flour and similar products, as well as exploding firecrackers, are included in the aforesaid category;
- 4) Discharging water and liquids used for washing and cleaning both by businesses and private individuals;
- 5) Throwing foam, chemical substances, debris or waste of any kind away or into fountains and public water tanks;
- 6) Wetting, washing oneself and/or cleaning oneself in public water tanks and fountains, or using them to wash things;
- 7) Camping or abandoning waste or lying in streets, in squares, on pavements, under porticoes, causing inconvenience and disturbance, or obstructing entrance;
- 8) Disturbing the regular execution of the activities carried out inside public structures and structures for public use, as well as using said structures in a manner different from the one established;



- 9) Satisfying bodily functions outside the pertinent places. It is also forbidden to spit, both for health and hygiene reasons and to avoid soiling public places;
- 10) Abandoning and/or leaving unattended effects or other unaccountable material as waste;
- 11) Soiling or damaging monuments, fountains, public buildings or façades, both visible and not from public roads;
- 12) Climbing up and/or down monuments, poles, furnishings, signs, gratings and other public or private property;
- 13) It is also forbidden to enter and stop under porticoes, open galleries, entrance halls and stairs of buildings that are open to the public in order to eat, sleep and carry out acts in them that violate their cleanliness and the rules of decorum.
- 14) Any violation of the previous points leads to the imposition of an administrative fine and the obligation to immediately restore the places to their original state.

### **SECTION 3 : CLEANLINESS AND DECORUM IN PUBLIC SPACES AND AREAS**

#### **Art. 7: Pavements and porticoes**

- 1) Excluding what is indicated by the urban planning rules and regulations in force:
  - a) the floors of porticoes and pavements are built by the owners of the buildings they are part of or by the City Council;
  - b) building owners must carry out maintenance on the pavements that belong to them, including those facing the roads.
- 2) Vehicles, of any type, cannot be used under the porticoes, even if pulled by animals; the only exclusions are means for cleaning and means for transporting children and people with reduced walking abilities.

#### **Art. 13 : Branches and hedges**

- 1) Branches and hedges that protrude into public areas from private property must be pruned by the owners or tenants whenever they create a dangerous situation or become an obstacle.
- 2) Branches that protrude at a height of 2.70 m above the pavement, and that protrude at a height of 5.50 m above the roadway, are permitted in a limited manner. Owners must prune all the plants in question if so requested by the Local Police. The cut branches and cutting residues must be removed and duly disposed of by the subjects pursuant to paragraph 1, as indicated by laws in force.
- 3) Any violation of the previous points leads to the imposition of an administrative fine and the obligation to restore the places to their original state.

#### **Art. 17 Hanging laundry and rugs**

- 1) It is forbidden to shake out rugs, cloths and similar objects in areas that are public or open to public passage, as well as to hang them from windows or above the parapet of terraces or balconies overlooking public spaces and areas, if they create disturbance or danger.
- 2) The violation of the previous point leads to the imposition of an administrative fine and the obligation to restore the places to their original state.



#### **Art. 19 : Mobile objects.**

- 1) Mobile objects placed on window sills, balconies, or on any other part that protrudes from the building, that overlook the area that is public or open to public passage must be suitably fastened to prevent them from falling.
- 2) Plants that are outside homes must be watered without disturbing, creating an inconvenience, or endangering the public transit.
- 3) The violation of the above specified points 1) and 2) leads to the imposition of an administrative fine and the additional penalty of restoring the places to their original state.

#### **Art. 24 : Pets**

- 1) Pet owners or handlers/carers must make sure that their pets do not disturb the neighbourhood, hurt people or damage things.
- 2) Pet owners or handlers/carers must also guarantee the health and hygiene conditions of the place where the animals live.
- 3) The violation of the points specified above leads to the imposition of an administrative fine.

#### **Art. 25 : Duties of animal owners**

Animal owners/handlers/carers must not:

- 1) allow their animals to soil porticoes, pavements or other public spaces with excreta. Anyone who takes animals to an urban area must have the tools suitable for collecting their animal's faeces and use them to collect said faeces;

### **ADMINISTRATION AND CONSUMPTION OF ALCOHOLIC BEVERAGES**

#### **Art. 28 : administration of beverages of any alcoholic strength**

- 1) All owners of public establishments (bars), or people authorised to pour alcoholic beverages must not allow glass or ceramic containers (bottles, glasses, cups, etc...) that contain alcoholic beverages of any alcoholic strength to leave their premises, in order to avoid said objects being used as "improper weapons" in the hands of people in an impaired physical and mental state.
- 2) The violation of the previous point leads to the imposition of an administrative fine.
